The Nebraska Association of Public Employees (NAPE/AFSCME Local 61) is the union that represents you in your employment with the State of Nebraska. The NAPE elected negotiation team has reached a tentative agreement with The State of Nebraska on a new labor contract to run from July 1, 2019-June 30, 2021.

The tentative contract must now be ratified by the NAPE membership. We want to take this opportunity to invite you to our ratification meetings. Members will have the opportunity to vote at the meeting, while non-members are welcome to listen to the presentation. Only NAPE members have the right to vote to accept or reject the agreement, however, you could choose to join the union at the ratification meeting and have the right to vote immediately.

Ratification meetings will be held around the state during the coming weeks. A schedule is including in this mailing. All meetings will last less than one hour, and you may attend a meeting at any location that is convenient for you. Members of the negotiation team will go over all the details of the agreement and answer any questions you may have regarding the contract.
